

What data do we collect?

Dynamic Computer Systems collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Business information (job title, company, etc.)

How we collect data

You directly provide Dynamic Computer Systems with most of the data we collect. We collect data and process data when you:

- Voluntarily complete a customer survey or provide feedback via email.
- Subscribe to our newsletter.
- Use or view our website via your browser's cookies.

Dynamic Computer Systems may also receive your data indirectly from the following sources:

- Google Analytics
- Social Media Platform Analytics (such as Facebook, Twitter, LinkedIn, etc.)
- Contact Database Platforms (such as MailChimp or Constant Contact)

How we use your data

How we store your data

Once it becomes irrelevant or you request its deletion, we will delete your data by manually removing it from our managed databases.

Your data protection rights

Dynamic Computer Systems would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

- The right to access – You have the right to request for copies of your personal data.
- The right to rectification – You have the right to request that Dynamic Computer Systems correct any information you believe is inaccurate. You also have the right to request Dynamic Computer Systems to complete information you believe is incomplete.
- The right to erasure – You have the right to request that Dynamic Computer Systems erase your personal data, under certain conditions.
- The right to restrict processing – You have the right to request that Dynamic Computer Systems restrict the processing of your personal data, under certain conditions.
- The right to object to processing – You have the right to object to Dynamic Computer Systems processing of your personal data, under certain conditions.
- The right to data portability – You have the right to request that Dynamic Computer Systems transfer the data that we have collected to another organization, or directly to you, under certain conditions.
